#### New Business

- Presidential Appointments
  - Brian Kuntz appointed Cameryn Kinderknecht as the 2026 KWHA secretary
  - Brian Kuntz appointed Kevin Solofra as the 2026 points recorder
    - Norleen Knoll moved to approve; Camisha Stevenson seconded; motion passed
  - Historian, Parliamentarian, and Points Auditor to be determined at a later date
- January Meeting: Discussion was had on when and where to have the January Meeting. It was suggested to have the meeting at the Hays Fairgrounds on 1/11/26 starting at 10:00am. It was discussed and settled to have a soup potluck lunch.

- 2026 Show Season: Brian Kuntz suggested the show season begin February 28<sup>th</sup>, 2026, and end August 16<sup>th</sup>, 2026, with entries needing to be postmarked by August 18<sup>th</sup>, 2026. Kevin Solofra confirmed this would allow him enough time for entries and double-checking points before State Show.
- Benefit Show date: Howard Sauer suggested discussing the Benefit Show date to allow for clubs time to plan around that weekend. Glenda Ratliff moved to schedule the Benefit Show for June 5<sup>th</sup>, 6<sup>th</sup>, and 7<sup>th</sup>, 2026, (the first weekend in June as in past years). - Scholarship Show date: It was also brought up to nail down the Scholarship Show date to allows clubs to schedule around that weekend.
